NB **Company Constitution.** *It is common practice for companies with more than one director and/or shareholder to have a constitution. In our opinion, one-person-companies are initially better off without a constitution. However, a constitution can be prepared later for an additional fee if it becomes appropriate.*

Company Registers Folder/Book. *Company register is a set of the statutory documents requirements of the Companies Act 1993. They include (but are not limited to): minutes; register of directors; register of certificates; interests register; register of members; share register; register of fixed assets; register of charges; constitution. There can be fines of up to \$10,000 if these documents are not maintained by Companies and their Directors.*

Trademark Search. *Trademark Search ensures that at the time of company incorporation no confusion is going to happen in the marketplace between the name of your company and any existing registered trademark. Trademark Registration is a separate and more complicated process. Companies whose name creates confusion in the marketplace with any existing registered trademark in NZ will be liable to the proprietor of the trademark for the tort of passing off which would result in very significant potential liability.*

LAQC Check. *Please note that we only make sure the details you provide for your company will pass the Inland Revenue Department criteria to LAQC election. The actual LAQC election will have to be done by the shareholders and directors after you register for an IRD Number.*

Registered Address. *Each company must have physical Registered Address and Address for Service in New Zealand. If such one is not available on the moment of the application you can use BizOffice's address. This is annual fee.*
